## **REGULATIONS OF THE LONG ISLAND RAIL ROAD GOVERNING THE SALE OF MONTHLY SCHOOL COMMUTATION TICKETS**

Subject to tariff schedule rules and regulations, monthly school commutation tickets are good for one continuous ride in each direction each day between the stations named on the ticket during the calendar month for which the ticket is issued and is for the sole use of the person in whose name it is used. These school tickets are for sale only to students under 21 years of age in attendance at accredited public or private elementary or secondary schools, provided such students are pursuing therein a general educational course. The term "elementary" school will be construed to mean school teaching students in grades 1-8. The term "secondary" school will be construed to mean a school teaching students in grade 9-12. Tickets will also be sold to students attending "junior" high schools which each student grades 7-10. Tickets will not be sold to students attending any other type of school, including colleges, universities, business or commercial schools, high school work-study programs, or dancing, swimming, riding, dressmaking, physical education, typewriting, stenography, or similar specialty schools, nor to pupils of music teachers, art studios or institutions of a like character for training in a single branch, whether mechanical, musical, or otherwise.

Particular attention is called to the fact that school commutation tickets are not to be sold to or used by teachers or instructors.

School commutation tickets are not transferable, and if presented by any person other than the one named thereon, they will be taken up and forfeited.

Identification of holder as original purchaser must be established by signature to the satisfaction of any agent, conductor, or collector, whenever required.

Each student for a school commutation ticket must present a certificate of SPS-18 correctly and completely filled out and signed in ink by the student, also by parent or guardian of the applicant and by an officer of the school with the title of President, Registrar, Bursar, Recorder, Headmaster, Principal, Superintendent, Director, Directress, Treasurer, or Dean (including such titles when prefixed by "Vice", "Assistant", or "Associate"), or by an officer in a secretarial capacity, or by an official with title other than mentioned herein, provided that such title indicates that said official is in charge of the school. In all cases the official title of the person signing the certificate must be shown in connection with the signature.

In all cases the name and location of the school (including street and number) and name of school contact and telephone number must be shown on the form.

### **SIGNATURES ON TICKETS**

A school commutation ticket must be purchased personally by the person who is to use it, and signature affixed with pen and ink at time of purchase. No school commutation ticket shall be issued unless the purchaser at time of issuance affixes his or her signature, with pen and ink, in space provided therefore, and no such ticket will be valid or passage unless it bears purchaser's signature, made with pen and ink, in space provided therefore. Tickets also provide that the age of the purchaser shall also be known.
